- A \$100.00 check payable to the BVSA** (Applicable for new house, garage, stable, barn or shed over 120 square feet). This is a non-refundable review fee which is required each time a new set of plans is submitted for sympathetic approval.
- Plot Plan:** Two sets to scale showing property boundaries, setback distances and location of structures, trees (identify which to be removed/trimmed), septic tank, propane tank and screening, roads, and driveways.
- Floor Plans:** Two sets showing total square footage (show square footage of each floor if building is multi-storied). Include location and dimensions of garage, car port, decks, stairways, balconies, fireplaces, etc.
- Elevations:** Two sets of front, rear and side drawings to include exterior materials and colors. Show maximum total height.

***I understand that sympathetic approval is only an approval of the conceptual plans. I agree to submit plans to the Environmental Control Committee for approval prior to any "work" on the property.***
